The treasurer is requesting approval to transfer the following funds to follow the required set a side amounts per Section 3315.18: Section 3315.18 requires boards of education of city, exempted village, local and joint vocational school districts to establish a capital and maintenance fund for capital improvement and project maintenance purposes. The boards of education are required to deposit into this fund from their school districts' revenues, an amount that equals 3% of the preceding year's formula amount as defined in ORC 3317.02 multiplied by the previous year's student population of their districts.
